In agreement with the Status of the IRU and its articles in Chapter 7 regarding the Tasks and Obligations of the Roma IRU Kris, as well as the taken activities regarding the made decision to initiate an IRU Kris Process against Dorin Cioaba from Romania, for violating the Statutory Regulations from article 53 and 54 under all points, the Head of the IRU Kris - Gregor Julson and his formed team of independent IRU Kris judges: Robert Berger from Austria, Aleksandru Levers from Romania, Robert Botos from the Czech Republic, Todor Muto from Poland, Hajnel Vidov from Slovakia, Jurai Berliner from Ukraine and Milesku Angeluta from Romania.

On the day of 16.01.2017 starting from 17:00h through a Video Conference, the Process of the IRU Kris against Dorin Cioaba began.

During the 150 minute process in full composition of the IRU Kris made the following

D E C I S I O N

Dorin Cioaba must hand over the following documents to the IRU Kris Team in seven days, not later than the 22.01.2017 until midnight. These are the following documents:

1. Documentation for registration of his current illegal IRU, which must show where it is registered with a clearly highlighted headquarter of the IRU.
2. Argument and explanation for opening the illegal Account in the name of the IRU which is opened in Sibiu, Romania on the day of 08.10.2013 in BRD-Groupe Societe Generale RO35BRDE330SA73171973300.
3. To bring a document with the current financial situation of the IRU Account from the above mentioned period.
4. Explanation and documentation of the current appointments of the IRU Presidency, Treasurer, General Secretary in the period after August 2013 to March 2016.
5. Documents for the accusations of fraud of 500.000 Euros and the dispute with Gruia Bumbu, which received an accusation in the IRU Kris Process on the 2nd of December in 2015 in the Office in Sibiu, Romania.
6. To explain why he did not directly attend the process of the IRU Kris against him held on 16.01.2017, although he was timely and correctly informed and invited to attend. Also, Dorin Cioaba sent a short email after the invitation to attend the Process. In his email he said that he does not approve this IRU Kris as valid.

All of these decisions are made in accordance with the IRU Statute and was approved by all of the above mentioned Kris Judges from this Process against Dorin Cioaba.

The final Decision of the IRU Kris will be presented on the 24.01.2017 not later than 16:00h.

The process ended on 19:45.
